### PULMONARY CT ANGIOGRAPHY

#### Technique:

CT study was done on Siemens Dual Source CT, SOMATOM Drive machine using the standard C.T. protocol with high luminal contrast enhancement (using 20.c. non-ionic 350mg / ml).

**Follow-up case of CCTGA with VSD + Pulmonary atresia followed by PDA stenting.**

#### Findings:

##### Summary:

- *Situs solitus; levocardia.*
- *D-loop configuration of ventricles is noted; morphological right ventricle is located on right side and morphological left ventricle is noted on left side.*
- *Atrio-ventricular concordance & ventriculo-arterial discordance.*
- *Large subaortic VSD.*
- *Dilated RA and RV.*
- *TGA with L-malposed aorta.*
- *Patent PDA stent is seen.*
- *No pericardial effusion is seen.*

##### Cardiac chambers:

- *Situs solitus; levocardia.*
- *D-loop configuration of ventricles is noted; morphological right ventricle is located on right side and morphological left ventricle is noted on left side.*
- *Atrio-ventricular concordance & ventriculo-arterial discordance.*
- *Large subaortic VSD.*
- *Dilated RA and RV.*
- *No pericardial effusion is seen.*

##### Pulmonary arteries:

- *Pulmonary atresia is seen.*
- *Confluent branch pulmonary artery is seen.*
- *The distal MPA measures approx. 9.8mm.*
