FINAL DIAGNOSIS

- Situs solitus, Levocardia
- Normal Segmental Analysis
- Restricted PM VSD (left to right shunt)
- Dilated LA/LV
- Normal ventricular function
- Normal sinus rhythm
- S/P VSD device closure done using Konar MF device of size 8 mm x 6 mm on 28/08/2024

RESUME OF HISTORY

SHIVAM MAURYA is 8 a years old male, 1st in birth order, born as full term normal vaginal delivery with birth weight of 2.9kg, cried immediately after birth. On routine examination patient was diagnosed to have VSD, for which patient was on regular follow up. In view of Dilated LV. Patient was planned for VSD device closure at FEHI.

On examination, his pulse rate was 102/min regular RR 18/min. Saturation in room air 100 %. There was no pallor, tachypnea, cyanosis, clubbing, jaundice or edema. Bilateral air entry present. Precordial examination revealed apex in left 4th ICS at MCL. S1 normal, S2 wide and variable split. Pan systolic murmur grade III/VI present at left lower sternal border. Rest of the systemic examination was unremarkable.

HEIGHT ON ADMISSION : 138 CM

ECG	: Normal sinus rhythm
CHEST X RAY	: increased pulmonary blood flow

: Done on 25/08/2023 revealed restrictive perimembranous VSD (left to right shunt), restricted by STL. Laminar inflow and outflow. No AR. Confluent branch PAs. Laminar flow in arch. No coarctation of aorta. No PDA. Normal LVEF. Dilated LV. LVIDd= 4.4cm (z score= +1.8). LVIDs= 3.0cm (z score = +2.0). LA= 2.4cm (z score= +1.1).

PRE DISCHARGE ECHO

: Done on 29/08/2024 revealed VSD device in situ. No residual shunt. Laminar inflow. Trace TR (max PG = 15 mmHg). Laminar outflows. Laminar flow in arch. No coarctation of aorta. Normal LVEF. No collection.

COURSE IN THE HOSPITAL

SHIVAM MAURYA was admitted in Fortis Escorts Heart Institute, New Delhi for VSD device closure. He underwent VSD device closure done using Konar MF device of size 8 mm x 6 mm on 28/08/2024 (report attached). Post procedure he was kept in CCU for monitoring. He was hemodynamically stable throughout his stay. He is being discharged in stable condition with advice to regular follow up.

CONDITION AT DISCHARGE: Stable

PLAN FOR CONTINUED CARE:

- TO SEE DR NEERAJ AWASTHY AFTER ONE WEEK IN PEDIATRIC ECHO LAB
- ECHOCARDIOGRAPHY TO BE DONE AFTER THREE MONTH, SIX MONTH, ONE YEAR

DIET : Normal

ACTIVITY : Avoid strenuous activities for 3 months

MEDICATIONS

- Syp. Cefixime (100mg/5ml) 5ml orally twice daily X 3 days - 10am - 10pm
- Syp. Paracetamol (250mg/5ml) 5ml SOS for fever or pain
