RESUME OF HISTORY:

SHIVANSH DUBEY is a 3 ½ years old male, 2nd in birth order, born as full term LSCS delivery with birth weight of 2.5kg, he was admitted in immediate neonatal period for one week at Gorakhpur as a case of reparatory distress. Echo was done which showed PDA. There is history of recurrent history of URTI. Repeat echo was done in August 2021 at Max Saket, Delhi, and was advise PDA device closure. He is now admitted at Fortis Escorts Heart Institute, New Delhi for Device closure of PDA.

On examination, his pulse rate was 110/min, regular, RR 24/min. Saturation in room air 97%. There was no pallor, cyanosis, clubbing, jaundice or edema. Bilateral air entry present. Precordial examination revealed apex in left 5th ICS space lateral to MCL. S1 normal and S2 narrow split. Continuous murmur at left infraclavicular region present. Rest of the systemic examination was unremarkable.
